Chris plans to contact those renting the hall on January 29th to reiterate the hall capacity. Calvin Trovinger as the Borough EMC and a member of the RFC stated that he plans to have a "mock" drill at BH in the near future to determine concerns, needs, and matters that need attention in providing emergency services at BH should an emergency ever occur. No vote was necessary, Chris and Bo will keep the council informed, and the Parks & Recreation Committee will be looking at the contract to see if changes and additional information can be added to account for the maximum capacity.
