The original bid of \$59,802.50 was discussed as well at the additional quotes for repairs required In addition to the bid quote totaling \$9,996.24. Colby opened discussion to the residents in attendance. Colby stated that Covid Relief Funds can be used for part of this project. Curt Genner accepted the councils request for Wynn to inspect the project as well as communicate with AMS on the borough's behalf during this project. AMS will notify residents of the scope of work as it develops. Council thanked Curt for attending the meeting to discuss the bid for this project as he said goodbye.

**Motion made** by Jillian Snyder, seconded by Calvin Trovinger to approve Curt Genner, Borough Engineer to inspect the project as it develops for the New, Maple, and Second Street Project. All in favor. Motion carries.
