#### As read report:

- All of the inlets have been repaired and coated except for Main St. Andy and Jeff have started on Main St. and have a schedule worked out to do work on inlets and Jeff still mow.
- The Windsor development retention basin had a separated pipe and wash out, that pipe has been fixed and wash out fixed as well.
- The storm water outlet trench that runs across from Cherry St. Between 2 residents, the 4inch shale cap collapsed. The trench was opened up and a concrete lid was put in its place and backfilled.
- A couple of weeks back one of the storm water lines clogged up, Andy and I got a quarter of the pipe open but
  couldn't open it up all the way. Bucks County Water and Sewer came out and ran a camera in the pipe for me and
  located the grit that is blocking the pipe so now Franc Environmental is coming out this Friday at 9am to jet and
  vac the grit out of the pipe to open it back up.
- Andy dug out in front of the welcome sign at Benner Hall got it back straight again.
- Grass was growing over the blacktopping of the walking trail around Benner Hall, so Andy edged the walking trail.
