

**2022 ANNUAL DRINKING WATER QUALITY REPORT**

**WATER SYSTEM INFORMATION:**

We are pleased to report that our drinking water meets federal and state requirements. This report shows our water quality and what it means. If you have any questions about this report or concerning your water utility, please contact the Water Department at 215-538-9290. We want our valued customers to be informed about their water supply. Other questions and concerns can be brought to Borough Council, which meets on the second Tuesday of every month at 7 pm in Benner Hall.

**SOURCE(S) OF WATER:**

In 2022, our water source was ground water from three wells, designated as Well #1, Well #2 and Well #3, which draw from the Tohickon Creek Watershed which is underlain by the Brunswick Shale Rock Formation.

**Some people may be more vulnerable to contaminants in drinking water than the general population. **MONITORING YOUR WATER:**

We routinely monitor for contaminants in your drinking water according to federal and state laws. The following tables show the results of our monitoring for the period of **January 1 to December 31, 2022**. The State allows us to monitor for some contaminants less than once per year because the concentrations of these contaminants do not change frequently. Some of our data is from prior years in accordance with the Safe Drinking Water Act. The date has been noted on the sampling results table.

**DEFINITIONS:**

*Action Level (AL)* - The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

*Maximum Contaminant Level (MCL)* - The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

*Maximum Contaminant Level Goal (MCLG)* - The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

*Maximum Residual Disinfectant Level (MRDL)* - The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

*Maximum Residual Disinfectant Level Goal (MRDLG)* - The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

*Minimum Residual Disinfectant Level (MinRDL)* - The minimum level of residual disinfectant required at the entry point to the distribution system.

*Treatment Technique (TT)* - A required process intended to reduce the level of a contaminant in drinking water.

*pCi/L* = picocuries per liter (a measure of radioactivity)

*ppb* = parts per billion, or micrograms per liter ( $\mu\text{g/L}$ )

*ppm* = parts per million, or milligrams per liter ( $\text{mg/L}$ )

**INFORMATION ABOUT LEAD:**

*If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The Richlandtown Borough Water Department is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using the water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. #### **HEALTH EFFECTS:**

**ARSENIC:** While your drinking water meets EPA's standard for arsenic, it does contain low levels of arsenic. EPA's standard balances the current understanding of arsenic's possible health effects against the costs of removing arsenic from drinking water. EPA continues to research the health effects of low levels of arsenic which is a mineral known to cause cancer in humans at high concentrations and is linked to other health effects such as skin damage and circulatory problems.

\*The Level Detected for Arsenic is an average of the reported values for the year. It is considered compliant if the average value falls below the MCL of 10 ppb.

#### **VIOLATIONS:**

**Reporting Requirements Not Met for Chlorine:** On the 5<sup>th</sup> week of May (2022), chlorine residuals were taken but were inadvertently not submitted. We immediately submitted the results when we received notification that the results had not been received.

#### **EDUCATIONAL INFORMATION:**

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban stormwater run-off, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, and septic systems.
- Radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, EPA and DEP prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. FDA and DEP regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. #### **OTHER INFORMATION:**

Many of the levels that are reported in the level column are the maximum level detected in the range column. Only one sample was required to be taken at each entry point so the highest level was noted in the level detected column and lowest to highest level was reported in the range column.

Only detected values of regulated and unregulated contaminants are included in this report. EPA recommendations

state that undetected contaminants need not be listed. There were no detections of synthetic organic compounds. Unregulated contaminants are those for which the EPA has not established drinking water standards. The purpose of the unregulated contaminant monitoring is to assist the EPA in determining the occurrence of unregulated contaminants in drinking water and whether further regulation is warranted.
